2508 Transfer Review –Sanders

Homeschooled and lives in the Decatur boundary but now attends some classes at Curtis High School. Played for Stadium last season, thus is a transfer.

MOTION: It was moved by **B.F.** and seconded by **H.V.** to approve eligibility for Sub-Varsity competition at Curtis. In favor 6. Opposed 0. Abstain 1. Motion carried.

 Transferring from Chesterton Academy to Gonzaga Prep.

- 2510 Kamiak Request to add Meadowdale to conglomerate Schools are combining at the youth levels as well.
 MOTION: It was moved by B.F. and seconded by DH. to approve Meadowdale be added to Kamiak's conglomerate. In favor 8. Opposed 0. Motion carried.
- 2511 Meadowdale Senior

Snow – senior, attends Meadowdale, request to finish career with Shorecrest **MOTION: It was moved by B.F. and seconded by H.V. to grandfather Snow to play his senior year at Shorecrest. In favor 8. Opposed 0. Motion carried.**

- 2512 Shorecrest Request to add Edmonds-Woodway to conglomerate With Meadowdale being reassigned to Kamiak, request made to add Edmonds-Woodway to Shorecrest conglomerate MOTION: It was moved by B.F. and seconded by DH. to approve Edmonds-Woodway as part of the conglomerate with Shorecrest. In favor 8. Opposed 0. Motion carried.
- 2513 Kamiak- Ineligible players in 2024
 For the 2024 season, Kamiak listed two players as attending Montlake
 Terrace on both Sportability (online roster) as well as their official program
 roster submitted to their Region Rep. These players actually attended
 Meadowdale and thus were ineligible to be on the roster. The administrative
 adults involved (coaches and board president) are no longer with the
 program. Now that Meadowdale has been added to the Kamiak
 conglomerate, these players are eligible for the 2025 season.
 MOTION: It was moved by B.F. and seconded by R.J. to suspend the
 two players for the first league scheduled game of the 2025 season for
 false roster information. In favor 8. Opposed 0. Motion carried.

2514 Stadium - Ineligible player in 2024

For the 2024 season, Sanders participated with Stadium despite being homeschooled outside the district, with no association to the district or any school associated with Stadium's conglomerate.

MOTION: It was moved by B.F. and seconded by H.V. to suspend the Stadium Head Coach, Green for the first league scheduled game of the 2025 season for the roster violation during the 2024 season. In favor 8. Opposed 0. Motion carried.

2515 Sanders – Ineligibility

Sanders participated with Stadium in 2024 despite being ineligible. He has since enrolled at and attends classes at Curtis HS, thus is eligible to participate with Curtis for the 2025 season.

MOTION: It was moved by B.F. and seconded by H.V. to suspend Sanders for the first league scheduled game of the season for the violation during the 2024 season. In favor 7. Opposed 0. Abstain 1. Motion carried.

2516 Seattle Prep Head Coach to miss Mandatory Coach Meeting

MOTION: It was moved by D.H. and seconded by I.O. to excuse Coach Bennett from the January Head Coach Meeting due to outside circumstances. An assistant coach will attend in his place. In favor 8. Opposed 0. Motion carried.
